Processing of your data

teamdress has no influence over the data processed by LinkedIn, the type of processing, the use or transfer of this data to third parties and has no way of exercising any control over this. If you access our LinkedIn account or your own your personal data will be collected, transferred, stored, and used by LinkedIn. The data will be transferred, such as to the USA, and stored and used there regardless of your place of residence.

If a user is logged into their LinkedIn account at the same time when visiting the teamdress LinkedIn account, profile master data, such as the industry of the user's employer may be included in the statistical analysis. This information is not available if you log out of your LinkedIn account beforehand.
